Sealed bids or Electronic bids must be submitted to the office Tadi Rural Municipality, Kharanitar, Nuwakot by hand or through PPMO's e-GP system i.e [www.bopatra.gov.np/egp](http://www.bopatra.gov.np/egp) on or before as per mention below information, date and time. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at below mention date and time at the office of Tadi Rural Municipality, Kharanitar. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to as mentioned below, which shall be valid for 30 days beyond the validity period of the bid. If bidder wishes to submit the Cash Security, the cash should be deposited in Dharauti Account No. 02-133-00985850-01-9 at Agricultural Development Bank Limited, Kharanitar branch, Nuwakot and submit the receipt of the deposited amount of cash along with the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
