6. Bids shall be opened in the presence of Bidders' representatives who choose to attend at the office of 1:00 PM on **22nd October 2021**. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security amounting as stated below deposited at Dharauti account No.: **02-133-00985850-01-9** on behalf of Tadi Rural Municipality, Office of the Rural Municipal Executive, Kharanitar, at Agricultural Development Bank Limited, Kharanitar branch, Nuwakot or bid bond authorized from a recognized commercial bank of Nepal, which shall be valid for minimum 30 days beyond the bid validity period.
