- 6. Electronic bids must be submitted to the office *of Tadi Rural Municipality, Kharanitar, Nuwakot* through PPMO's e-GP system www.bolpatra.gov.np/egp on or before *12:00 Noon* on *2022/10/11*. Bids received after this deadline will be rejected.
- 7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 1:00 PM, 2022/10/11 at the office of Tadi Rural Municipality, Kharanitar, Nuwakot. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 40,000.00 deposited at Dharauti account No.: 02-133-00985850-01-9 on Agricultural Development Bank Ltd, Kharanitar branch, which shall be valid for 30 days beyond the validity period of the bid.
