5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 22-02-2024 13:00 at the office of Office of Tadi Rural Municipality, Kharanitar, Nuwakot. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of 25,000, which shall be valid for 30 days beyond the validity period of the bid (i.e. [Refer Clause ITB 20.1]). If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No.[0213300985850019] at [Agricultural Development Bank Ltd. , Kharanitar Branch, Nuwakot] and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
